SAFE ENVIRONMENT RECORD KEEPING

The Safe Environment Database (SETA Net) is a wonderful tool to help you track all three required elements of the Safe Environment Program. If used correctly, I can help you track background checks, abuse prevention policy acknowledgement and completed training that is required for employees and volunteers.

BACKGROUND CHECKS—To make sure background check records are linked to your employee or volunteer's record, ***please be sure to include the individual's SETA Net Participant ID when submitting your background check.***

ABUSE PREVENTION POLICY ACKNOWLEDGEMENT—To track if an individual has signed-off on the abuse prevention policies, simply enter the date the policy is signed on the participant's profile. You will find a box for this information on the Basic Info page under "Application Info."

DOES YOUR COMMUNITY HAVE A TRAINER???

Scheduling *Called to Protect* classes can be very easy if you have your own certified trainer available to you. In light of the ongoing need to train employees and volunteers, we encourage you to make sure you have a trainer (or two) in your parish/school community.

After completing the Train-the-trainer class, your trainer will be able to teach any of the *Called to Protect* classes: *Called to Protect for Ministries*, *Called to Protect for Parents & Families* and *Called to Protect for Youth*.

There is one more *Called to Protect: Train-the-Trainer* class scheduled this year: April 28/May 5, 2010 in Seattle.

TRAINING REQUIREMENTS FOR 2009-2010

- All new Church Personnel* are required to complete *Called to Protect for Ministries* within 90 days of beginning service.
- All returning Church Personnel*, who have completed *Called to Protect for Ministries*, must complete a safe environment training update in the Armatus program.
 - The Armatus program is an online training system which allows participants to take the class at their convenience, from any computer with internet access.
 - Log-on instructions are attached.
 - **ALL Training *must* be completed by May 31, 2010.**
- Each parish and school must offer *Called to Protect for Parents & Families* to their community. This may be offered in collaboration with the parish, school or deanery but **MUST** be made available and advertised to school parents once a year.
- Safe Environment Training in Level I Catholic Schools:
 - Pre-Kindergarten through Grade 3 will complete *Talking About Touching*.
 - Grade 7, Grade 9 and new high school students will complete *Called to Protect for Youth*.
 - Verification of all children/youth training is due on May 31, 2010.

**Church Personnel includes all clergy, all employees and any volunteer with ongoing unsupervised contact with minors or vulnerable adults.*
