### Use of Parish Property

Parishes are often inundated with requests from individuals, businesses, organizations, non-profit groups and performers to use parish property. This is especially prevalent during the holiday season. The State of Washington has strict requirements regarding the use of tax-exempt property. These rules have been consistent over the last several years. Tax-exempt property cannot be used to benefit any entity that is not a qualified non-profit.



This includes but is not limited to: performers selling cd's in Church, individuals selling books, medical screenings, parishioners selling PartyLite or Tupperware, teachers offering private music lessons or private tutoring, fundraising for individuals or families, any political activity, and advertising or soliciting for businesses.

If you have any questions regarding specific uses of property or receive special requests and need clarification, please contact the Property & Construction Office.

### Property & Construction Website

The Property and Construction page on the Archdiocesan website holds various contracts, agreements, guidance documents and resources that are useful for Parishes, Schools and Archdiocesan facilities. These documents are updated periodically. When using contractual-type documents, please check the website for the most current version of the document.

For example, did you know that the most recent "Facility Use Agreement" includes language about compliance of Safe Environment? Please take a look at this document and others.

### Safe Environment Program—Important Information

#### **CYO ATHLETICS**

Please remember that most CYO Athletics programs fall under the leadership of the local parish. Therefore, it is the parish's responsibility to ensure that all appropriate volunteers satisfy all Safe Environment Requirements. The parish's Athletic Director should provide a complete list of all Head Coaches, Assistant Coaches and CYO parent volunteers to the parish Coordinator and they should work together to ensure all coaches and CYO volunteers are compliant.

#### SAFE ENVIRONMENT TRAINING

How are all of your employees and volunteers doing on their Safe Environment training? Don't forget that <u>all</u> training must be completed and verification submitted to the Safe Environment Office by May 31, 2011. You are encouraged to set earlier training deadlines locally to ensure that everyone has completed training and you can meet the archdiocesan compliance verification deadline in May.
