### IRS Form 1099 Reminder

All independent contractors who received payments totaling more than \$600 in the 2010 calendar year must be issued a 1099 by January 31, 2011. Parishes, schools and faith communities must also complete an accompanying 1096 and submit it with copies of the 1099's to the IRS.

# Help Wanted-Assistant Director for the ACA

### **IRA Rollover**

#### Ready for some good tax news?

Congress has re-authorized the provision that allows donors to make tax-free charitable gifts from their IRA accounts in 2010 and 2011. Your parishioners who are age 70 ½ and older will be able to make gifts totaling up to \$100,000 from traditional IRAs to qualified charities, including the Archdiocese of Seattle.



Because Congress acted so late in 2010 to pass this legislation, donors can make a gift from their IRA until January 31, 2011 and still elect for it to count as a gift and as their minimum required distribution for 2010. To take advantage of this opportunity for tax year 2011, donors must act by December 31, 2011.

There are some details and restrictions:

- Donors must be 70 ½ or older when they make their gift, and the gift must be made from an IRA no other retirement plans qualify, such as 401k, 403b or SEP accounts.
- The gift must come to us outright it cannot be used to establish a life-income arrangement or support a donor-advised fund or certain types of supporting organizations.
- Although the distribution will be free from income tax, it will not generate an income tax charitable deduction.
- There are other details which the Planned Giving Office will be happy to guide you and your parishioners through.

As always, we would recommend donors to consult with their professional advisors when considering charitable donations.


### Renewal of Tax Exempt Status

# Social Networking Sites

A friendly reminder that according to the Code of Professional Conduct for Church Personnel (October 2007), "Social networking sites should not be used in connection with any official parish or archdiocesan program."

However, in light of the fact that social media is the fastest growing form of communication, it can be a very valuable tool in your programs. Currently, there is an archdiocesan steering committee looking at the use of social networking as a tool for communication in archdiocesan programs. They are considering a wide variety of issues that ensures we engage social media in a manner that is safe, responsible and civil.



- \* That there be adequate monitoring and administration of program pages (ideally by two or more administrators) to ensure all content posted is appropriate and consistent with Church teaching.
- \* That appropriate ministerial boundaries must be maintained online at all times.
- \* That there is no individual communication with minors and communication is only allowed on official program pages with prior permission from the parent/guardian.
- \* That no pictures of minors be posted without parent/guardian permission and that absolutely no pictures of minors are "tagged" with any identifiers (i.e., name, location).
- \* That parents/guardians must have access to anything provided to their children.
- \* That the main purpose in participating on a social networking site is for general communication about ministry, programs and events rather than chatting or socializing.

As you can see, there are many issues to take into consideration which make it extremely important that we are thoughtful and intentional about the policies that we develop. Stay tuned for developments!!

# Priest's Payroll

Payroll set-up for clergy can be very confusing and remains one of our most common problem areas in parishes and faith communities.

We are prohibited, <u>by LAW</u>, from withholding Social Security or Medicare from priest's paychecks. Priests are considered self-employed for Social Security purposes. This means that they pay the required self-employment tax on their individual income tax returns.

Priests can, however, elect to have Federal Income Tax withheld and can also elect to have additional tax withheld to help them cover their self-employment taxes. This amount must be withheld as additional FEDERAL INCOME TAX.

Please take the time to verify that your priest's payroll is set up correctly and that you are not withholding Social Security or Medicare from their paychecks. If you find that you are or have been withholding Social Security or Medicare, you will need to work with ADP to get the situation corrected.
