Legislative Update: February 25, 2011

Thank you to all of you who have contacted your legislators regarding \$8 5639! It is making a difference. Your voice is significant in determining the future of private school representation in governmental affairs that affect all of our schools. I have received many positive comments from both Senate and House members regarding your input. It has also been gratifying to hear from your parents and community members that have been vocal in their support of our issue.

To date, we have provided testimony to both Senate Education and Ways and Means Committees, spoken with staff and legislators in each of their offices, met with the Governor's policy director, and are working collaboratively to craft workable language to reinstate our representation in P-12 education in our state.

Our work is by no means over! Please continue to be available to work with WFIS to communicate with our elected representatives as this bill continues to move forward.

WFIS continues to work with the Washington State Catholic Conference to move House Bill 1163 (concerning harassment, intimidation, and bullying prevention) on to the next level. The substitute offered in the House on February 18, 2011, requires the Office of the Superintendent of the Public Instruction and the Office of the Education Ombudsman to establish an ongoing workgroup regarding prevention of bullying, intimidation, and harassment in public schools. The substitute bill specifies issues for the workgroup to examine and requires a biennial report. The substitute bill directs the State Board for Community and Technical Colleges and the Higher Education Coordinating Board to compile and analyze bullying and harassment prevention policies at colleges and universities and submit a report by December 1, 2011. The substitute also includes mental health and suicide prevention education in classroom-based assessments of health and fitness learning standards.

Substitute offered in the House on February 17, 2011, requires the DEL to establish timeframes for monitoring visits to non-expiring licensees. The substitute bill defines an agency in good standing as one that does not have: valid complaints; history of noncompliance related to those valid complaints or pending from prior monitoring visits; or, other information that when evaluated would result in a finding of noncompliance. The substitute bill also requires the DEL to consider whether an agency is in good standing when determining the most appropriate approach and process for monitoring visits, and clarifies that the license renewal process does not apply to non-expiring licenses.

Senate Bill 5848 (concerning education vouchers). Introduced by Sen. Dan Swecker(R) on February 22, 2011, to authorize parents who choose to educate their children outside the public education system to receive an education voucher for each child educated outside the public education system. This bill creates the education support account.

Even though the Annual State Budget continues to be the most critical of tasks facing our government, education continues to be at the top of the priority list for legislators. There have been 117 bills introduced. While many have little chance of passage, others can be critical to our schools without our representation at the table. Thank you again for your participation in the democratic process by making our voice heard in Olympia!
