The Elementary and Secondary Education Act (ESEA) and the Carl D. Perkins Act of 2006 require school districts to provide equitable services to eligible private school students, teachers, educational personnel, and parents under certain federal programs. Descriptions of the available federal programs are included in Attachment A.

Annually, private schools are required to notify the Office of Superintendent of Public Instruction (OSPI) and the local school district of their intent to participate in federal supplemental education programs through their local school district. The notification process is done via the Private Participation in Federal Programs (Intent to Participate) form on the Educational Data System (EDS), which is due to OSPI by **March 2, 2012.** 

## Private School Responsibilities

In order for a private school to access federal programs, it must meet the following criteria:

 Be a state approved, non-profit, elementary or secondary school. It must have submitted the annual certification through the State Board of Education (May 2011). BULLETIN NO. 087-11 TI/LAP/CPR Page 2 December 15, 2011

- Complete the Private School October Enrollment Report P105B form (October 2011). This information drives the allocation for services for the 2012–2013 school year.
- Submit the Intent to Participate form through the electronic process to OSPI by March 2, 2012. Instructions on how to access the form are included in Attachment B.

Please note: If the private school does not complete the Intent to Participate form by this date, its students, teachers, and other educational personnel will not be qualified to participate in services for the 2012–2013 school year.

Once the Intent to Participate form has been submitted, participating private schools will be contacted by their local school districts to begin the consultation process for services for the 2012–2013 school year. Consultation between the public school district and the private school needs to be "timely and meaningful." For a timeline of private school-related processes, see Attachment C, which outlines the responsibilities of OSPI, school districts, and private schools.

# School District Responsibilities

On an annual basis, the school district must contact private school officials and inquire as to whether the private schools' students and teachers will participate in the ESEA programs available to them. District applications for federal grant funding are subject to OSPI review and approval only when the Intent to Participate process is complete. Further guidance on meeting private school requirements can be found in Attachment D and on the OSPI ESEA Private Schools website: http://www.k12.wa.us/ESEA/PrivateSchools.aspx.

In addition, the school district is responsible for the following actions:

- Accessing the EDS site to view the list of eligible private schools. Instructions on how to access the site are included in Attachment E.
- Contacting the eligible private schools that have not yet completed the Intent to Participate form in order to determine participation.
- Documenting the attempted contacts with those private schools. Contact must be attempted at least twice and documented on the **Contact Log.** Instructions on how to complete the online Contact Log are included in Attachment E.
- Providing timely and meaningful consultation with eligible private schools that
  choose to participate in federal programs and services. The process must begin
  before the local school district makes any decisions that affect the opportunities
  of private school students, teachers, and parents to participate in federal
  programs requiring their equitable participation.
