## Compensation, Taxes and Our Friends at the IRS

If you look up the definition of "compensation" you will find something like this: Compensation is the total amount of the monetary and non-monetary pay provided to an employee by an employer in return for work performed as required. This is a pretty standard definition. You can split hairs over employee vs. Independent Contractor but essentially if you give somebody something for performing work for you it is compensation. As we all know, compensation is taxed.

Non-monetary compensation is taxable!! The compensation can be SCRIP cards, gift cards or, as a couple of our schools just found out, tuition credit. If you have a person doing any kind of work in exchange for tuition credit you are providing compensation to that individual and it must be reported appropriately to the IRS.

If the person is an employee and is doing the work in addition to his/her normal job, it must be added to the employee's W-2. The hours spent on the extra work are hours worked and the payment must be included in Social Security, Workers Comp, pension, etc. An individual cannot be an employee and an Independent Contractor at the same parish/school.

If the person is not an employee, the normal differentiation criteria between employees and IC applies so the individual might be considered an IC. In that case, if the compensation exceeds \$600 annually, you must issue a 1099.

We know the IRS is looking at non-profits more closely now and have had or will be having several IRS parish audits. This is an area that can cost a lot of money if it is not handled correctly so make sure you are in compliance.



## Help Wanted



- Mail Sort and Bank Deposit Duties will include sorting the mail, reconciling
  parish summary sheets to enclosed pledge cards, categorizing donations, preparing batches for deposit, completing deposits to the bank, and other duties as
  assigned. Approximately 40 hours/week Monday thru Friday from 10am to 6pm.
- Data Entry and Filing Duties include entering gift information into Raisers
  Edge database, filing completed gift batches, and other miscellaneous duties as
  assigned. Scheduled hours for data entry positions will be between noon and
  8pm Monday thru Friday and may be less than 40/hours week.

Projected dates for this temporary employment are May 7, 2012 thru June 15, 2012. Depending on response to the fundraiser these dates could end prior to June 15<sup>th</sup> or extend beyond June 15<sup>th</sup>. Employment is contingent on passing a background check. Flexibility regarding number of hours worked each day is helpful as work is dependent on how much mail is received every morning. If interested, please send a completed Chancery application to the Human Resources Department by April 10, 2012. The position being applied for is "Appeal Temp". Hourly rate ranges from \$12 to \$15/hour. Training for Raisers Edge and other duties provided by the Archdiocese.

All stock donations are processed through Parish Financial Services. When a parish receives a stock gift, the Pastor, Priest Administrator or Pastoral Coordinator will receive a letter stating the amount that was deposited into the PRF account, the name of the donor and the number of shares given. The donor will receive a copy of the same letter along with an official tax receipt.

Please do not include this contribution on the donor's year-end tax letter generated by the parish. Because a gift of stock is considered a "non-cash gift" we cannot assign a dollar value to the donation. It is the donor's responsibility to determine the value of the stock for tax purposes. We've received multiple calls from parishioners or their tax-advisors upset by the amount that was documented on the parish records. Donations of stock usually hit our accounts one to two business days after it leaves the donor's account. The value of the stock can vary dramatically in as little as 24 hours.





## Safe Environment Updates

#### SEP COORDINATOR WEB CONFERENCE

There are still a few spots left for the SEP Coordinator Web Conference on **Tuesday**, **28 February at 10am**. If you are a new SEP Coordinator, or were not able to join us for the first session, please join us.

Intended for all SEP Coordinators in the parishes, schools and archdiocesan programs, new or existing, this web conference will be an opportunity to talk about Safe Environment requirements, annual verification and the SETA Net Database.

Unfortunately, the session can only accommodate 40 SEP Coordinators. Please register **online on SETA Net**, to reserve your space. Only the SEP Coordinators who register in advance will receive the log-in instructions for the conference.

#### INDEPENDENT ORGANIZATIONS: BOY SCOUTS

As you know, there are organizations that minister within the Archdiocese of Seattle which are independent and not part of the Corporation of the Catholic Archbishop of Seattle. In terms of Safe Environment, Independent Collaborators in Ministry must fulfill the requirements outlined by the *Charter for the Protection of Children and Young People* (USCCB, 2005) but they do so independently of the Archdiocese of Seattle. Parishes do not run their background checks, provide training or have them sign the Safe Environment Policies. (See page 11 of the Safe Environment Program Coordinators Handbook for more information.)

However, some groups are less obvious whether they are a parish program or an independent organization. For example, Boy Scouts have some troops that are parish troops and some that are independent, which can be confusing. We hope this may clarify their Safe Environment status.

**Parish Chartered Troops** — If a Boy Scout troop is "chartered" by the parish, then it is considered an official parish program. As with all other parish programs, all Safe Environment policies of the Archdiocese of Seattle must be followed and the parish is responsible to ensure Safe Environment compliance.

**Non-Parish Chartered Troops** — However, some troops are <u>not</u> chartered by the parish. They are completely independent and simply use a room in the parish to meet. These troops will not participate in the archdiocesan Safe Environment Program. However, they must have a signed "Facility Use Agreement" which also states that they have met the obligations of the *Charter* (background checks, abuse prevention training and abuse prevention policies) in accordance with the policies of Boy Scouts of America.

A "Facility Use Agreement" is available from the Office of Property & Construction.

The national date for the CRS Collection is always Laetare Sunday, the fourth Sunday of Lent. This year, the CRS Collection falls on the weekend of **March 17-18**, **2012**.

#### Who benefits from CRS' Operation Rice Bowl?

CRS' Operation Rice Bowl contributions support projects that assist the poor both overseas and here in the United States. 75 percent of CRS' Operation Rice Bowl contributions are sent to Catholic Relief Services and help fund development projects overseas that help increase and maintain communities' access to food. 25 percent of the contributions remain in the dioceses in the U.S. and are used to fund local poverty and hunger alleviation programs.


#### How can I fully promote the USCCB's CRS Collection?
