APRIL CHILD ABUSE PREVENTION MONTH

April is National Child Abuse Prevention Month! Part of a nationwide effort to increase awareness about child abuse and abuse prevention, National Child Abuse Prevention Month is a great opportunity to pray for the eradication of child abuse and the protection of all God's children. DOES YOUR PARISH OR SCHOOL HAVE A CALLED TO PROTECT TRAINER??

2012 SAFE ENVIRONMENT VERIFICATION

With the arrival of spring, we look toward the annual Safe Environment Verification Process. The verification process is the same as in past years: the pastor, assigned pastoral leader or principal must sign and return the original Verification of Safe Environment Compliance form before May 31st. Pastors/assigned pastoral leaders and principals should have received their verification packets last week.

This year, please take an extra moment to evaluate your Safe Environment record-keeping. Please remember that evidence of Safe Environment compliance must be retained on every employee and any volunteer with ongoing unsupervised contact with minors or vulnerable adults including: criminal background check authorization, information sheet and results; signed copy of the "Church Personnel Agreement Form" and copies of training verification for all Safe Environment training. All Safe Environment obligations must be completed and verification of compliance received by May 31, 2012.

Real Property tax statements that are mailed from the counties to the Archdiocese have now been mailed to respective parishes, schools and entities. Please check and make sure that you have all the tax statements you were expecting. First-half payments are due by April 30. *Please call us if you have a tax statement that does not belong to you.* Call if you have any concerns or questions, 1-800-809-4923 or 206-382-4851.

Operation Rice Bowl

How does your parish collect Rice Bowl donations?

With each of our parishes participating in the Rice Bowl Lenten program, there are many and often very creative ways that communities observe the end of Lent with reception of donations to Operation Rice Bowl! Just one of the ways as noted by our Liturgy Office:



The Roman Missal directs that there "may be a procession of the faithful with gifts for the poor" on Holy Thursday. In many parishes that has meant a custom during Holy Thursday liturgy of individuals bringing the results of participation in "Operation Rice Bowl" and walking in procession to a common collection basket incorporated with the presentation of bread and wine. That's a wonderful custom and is certainly consistent with the direction in the Roman Missal for Holy Thursday.

Whatever your method – thanks!

- Using the Bulletin Announcements sent to each parish in January, and available at http://orb.crs.org/resources/parishes, inform members of your faith community about how the Rice Bowl donations will be used. (75% of donations support Catholic Relief Services' development programs in more than 40 countries around the world. 25% of donations support local hunger and poverty alleviation efforts in our archdiocese through nearly 200 grants.)
- Instruct the members of your faith community on how the donations will be collected in your parish. Here are two possible collection methods.
- Request that each member of your faith community count the money in his/her Rice Bowl and return a check made out to your parish or school at a designated time and place.
- Request that each member of your faith community return his/her Rice Bowl to your parish at a designated time and place.
- Using the Bulletin Announcements thank the members of your faith community for participating in Operation Rice Bowl. Our office will be sending a "thank you" letter to the pastoral leader, a week after we receive your parish check; some folks use that message in the parish bulletin or newsletter.

By May 31 please send a parish (or school) check for representing the community's giving to: Missions Office/Rice Bowl, 710 9th Ave, Seattle WA 98104. Again, *Thanks!*

Be Smart - Drive Safe is a condensed 18 minute online defensive driving course. This informative – yet entertaining – course will provide the trainee useful information to become a better defensive driver. Be Smart – Drive Safe is available at **no cost** and can be easily accessed and viewed when it is most convenient for the trainee!

How does *Be Smart - Drive Safe* benefit my parish or school?

By asking any employee or volunteer who drives on behalf of the church or school to take this course, safer transportation will be provided and the church or school will reduce its liability exposure to an auto loss!

How does *Be Smart - Drive Safe* Benefit the trainee?

The trainee becomes a better defensive driver AND can possibly be eligible for a reduction in their personal insurance rates!

WHO SHOULD TAKE BE SMART - DRIVE SAFE?

Ideally, anyone that drives on behalf of your church or school should be asked to take the course.

HOW DO WE ADMINISTER THE BE SMART – DRIVE SAFE PROGRAM AT OUR CHURCH OR SCHOOL?

Ideally, the church or school should designate a transportation coordinator(s) at your facility. The transportation coordinator identifies drivers and provides those drivers the *Be Smart - Drive Safe* handout. The transportation coordinator will need to determine the individual(s) from their location who will receive email confirmation that a driver has completed the training. The coordinator then simply adds the email address of the individual(s) to the *Be Smart - Drive Safe* handout.

How can we properly screen those who drive for our church or school and determine if they are eligible to drive?

The transportation coordinator will be emailed results to the screening questions completed by the trainee at the end of the training. The coordinator will simply need to take a quick look at the results and any answers printed in "red" will indicate a potential problem driver. In these cases, the trainee should not be allowed to drive on church or school business. As an added bonus, Be Smart – Drive Safe replaces the need for the driver to complete the Driver Information Sheet!

How can driver's access *Be Smart – Drive Safe?*

Enclosed is a handout that provides detailed instructions to access the *Be Smart – Drive Safe* training program. This handout can be distributed to anyone that drives on behalf of your church or school.
