

DISCIPLES CALLED TO WITNESS: THE NEW EVANGELIZATION

The U.S. bishops want to provide an opportunity for all Catholics to deepen their relationship with Jesus Christ, according to a new document from the U.S. Conference of Catholic Bishops (USCCB). *Disciples Called to Witness: The New Evangelization* focuses on reaching out to Catholics, practicing or not, who have lost a sense of the faith in an effort to re-energize them.

"Every Catholic has a role in the Church, and every Catholic is called to spread the Gospel," said Bishop David L. Ricken of Green Bay, Wisconsin, chairman of the USCCB Committee on Evangelization and Catechesis. "But in order to evangelize, a person must first be evangelized. This is really the heart of the New Evangelization."

The document examines what the New Evangelization is, its focus, its importance for the Church and how dioceses and parishes can promote it. "The New Evangelization is a call to each person to deepen his or her own faith, have confidence in the Gospel, and possess a willingness to share the Gospel," the document states. "It is a personal encounter with the person of Jesus, which brings peace and joy. The New Evangelization provides the lens through which people experience the Church and the world around them."

The document highlights the call of Pope Benedict XVI to pursue the New Evangelization with renewed vigor and joy. It also provides dioceses and parishes with resources to assist Catholics in renewing their faith and sharing it with others. Bishops Appeal Federal Decision: Anti-Trafficking Service Contract

The United States Conference of Catholic Bishops (USCCB) filed a notice of appeal April 17, asking a federal appeals court to vacate a decision by a Massachusetts federal judge declaring that the U.S. Department of Health and Human Services (HHS) violated the First Amendment in its contract with USCCB to provide case management services to victims of human trafficking, because the contract did not require USCCB to facilitate abortion and contraception. USCCB has also requested a stay of the lower court's decision until the appeals court can rule.

The decision came in a lawsuit filed by the American Civil Liberties Union (ACLU) against HHS in 2009. USCCB joined the lawsuit in mid-2010 on the side of HHS as a defendant-intervenor.

For five years ending last fall, MRS had successfully implemented a national government contract that helped men, women and children recover from the effects of human trafficking as victims of forced labor and the sex trade. Neither the statute authorizing the government funds, nor the request for contract proposals from potential providers like USCCB, required the



provider to facilitate abortion or contraception funding; and no trafficking victim complained for lack of government funding of these things under the contract. You can read the full statement at http://www.usccb.org/news/2012/12-064.cfm.



U.S. Bishops Join Call To Ban Landmines

Bishop Richard E. Pates of Des Moines, Iowa, chairman of the Committee of International Justice and Peace of the U.S. Conference of Catholic Bishops (USCCB), has joined a call from 76 nongovernmental organizations to President Obama, urging the United States to relinquish antipersonnel landmines and join the 1997 Mine Ban Treaty without further delay.

"This is a crucial humanitarian decision that should not be put off any longer, or postponed during a busy election year," the organizations' representatives said in an April 4 letter. "We urge you to submit the treaty to the Senate this year for its advice and consent next year."

The letter comes as the Obama administration concludes the comprehensive interagency review of its landmine policy, initiated in December 2009, and enters the decision-making stage. Since starting the review, the letter notes, the administration has received letters of support for the Mine Ban Treaty from 68 Senators, 16 Nobel Peace Prize Laureates, key NATO allies, retired senior military personnel, dozens of NGO leaders, victims of U.S. landmines, and countless concerned Americans.

It notes that 161 countries are signatories to the Mine Ban Treaty, including every member of NATO except the United States, as well as every member of the European Union, and other key U.S. allies such as Afghanistan and Iraq. The United States is one of only 37 countries in the world that have not joined the Mine Ban Treaty and the only country in the Western Hemisphere aside from Cuba that has not joined.



Signers of the letter included representatives of the Evangelical Lutheran Church in America, the United Methodist Church, Church of the Brethren, the Conference of Major Superiors of Men, Evangelicals for Social Action, Presbyterian Church (USA), Human Rights Watch, the Islamic Society of North America, Jesuit Refugee Services/USA and Pax Christi USA.

Federal Budget Choices Must Protect Poor, Vulnerable People



As Congress began working on the FY 2013 budget and spending bills this week, the U.S. Conference of Catholic Bishops (USCCB) wrote several letters that repeated and reinforced the bishops' ongoing call to create a "circle of protection" around poor and vulnerable people and programs that meet their basic needs and protect their lives and dignity. The bishops' message calls on Congress and the Administration to protect essential help for poor families and vulnerable children and to put the poor first in budget priorities. The bishops' letters oppose measures that reduce resources for essential safety net programs.

In the letters, Bishops Stephen E. Blaire of Stockton, California, and Richard E. Pates of Des Moines, Iowa, chairmen of the Committees on Domestic Justice and Human Development and International Justice and Peace, respectively, urged Congress to resist proposed cuts in hunger and nutrition programs at home and abroad saying that "a just spending bill cannot rely on disproportionate cuts in essential services to poor and vulnerable persons."

On April 4, Bishop Blaire cautioned that "at a time when the need for assistance from [affordable housing] programs is growing, cutting funds for them could cause thousands of individuals and families to lose their housing and worsen the hardship of thousands more in need of affordable housing." He also reminded Congress that the Catholic community is one of the largest private, nonprofit providers of affordable housing in the country and is deeply involved in meeting the health housing and nutrition needs of families across the nation.

Bishops Blaire and Pates reaffirmed the "moral criteria to guide these difficult budget decisions" outlined in their March 6 budget letter:

- 1. Every budget decision should be assessed by whether it protects or threatens human life and dignity.
- 2. A central moral measure of any budget proposal is how it affects "the least of these" (Matthew 25). The needs of those who are hungry and homeless, without work or in poverty should come first.
- 3. Government and other institutions have a shared responsibility to promote the common good of all, especially ordinary workers and families who struggle to live in dignity in difficult economic times...

Just solutions, however, must require shared sacrifice by all, including raising adequate revenues, eliminating unnecessary military and other spending, and fairly addressing the long-term costs of health insurance and retirement programs. Navigating Course II: Who is Jesus Christ?



In the highly Christological USCCB Framework sequence, Course II: Who Is Jesus Christ, provides the core opportunity for teens to know and understand how God fully reveals himself in his Son, the Second Person of the Trinity. Certainly, as with the other Framework courses, no apology is made for expecting the students to master some basic information including a deeper understanding about Revelation, the Trinity, the Incarnation, Marian dogmas, and discipleship. However, this course asks students to reflect on the meaning of what they are learning and to judge the relevance of Jesus to their personal lives.

The course asks teens to provide an answer to the question, "Who do people say that I am?" Moreover, it returns to the corollary: "Who do you say that I am?" The webinar will offer a basic survey of Course II along with some enrichment exercises that can be offered in a variety of places throughout the course. This webinar, presented by Michael Amodei on Thursday, April 26 at 3:30 p.m. EDT, is geared to high school religion teachers and catechists. Mid-Atlantic Catholic-Muslim Dialogue Creating Interreligious Education Guides

Representatives of the Mid-Atlantic Catholic and Muslim Dialogue have brought to near completion their multi-year project of two guides entitled Understanding Islam: A Guide for Catholic Educators and Understanding Catholicism: A Guide for Muslim Educators. While final edits will be performed by individual drafting committees, the dialogue participants anticipate that this project will be complete before the group reconvenes in 2013.

The draft version of *Understanding Islam: A Guide for Catholic Educators* was presented at the plenary session by main contributor Sandra Keating, Ph.D., of Providence College. The document, which is intended to serve as an introduction to Islam for Catholic educators, provides an interpretation of Islam that is faithful to how individual Muslim educators understand and teach their religion. Overall, the document provides a brief historical survey of Islam, as well as

a description of the holy Qur'an, the rise of the Ummah and Shar'ia law, including its five pillars, and a brief consideration of contemporary issues.

The draft version of *Understanding Catholicism: A Guide for Muslim Educators* was presented via teleconference at the plenary session by Shaykh Aboor Rahman Khan, the main contributor to the document. This document describes some of the central tenets of the Catholic faith, as well as the basic differences between Catholics and other Christians. It also provides an historical retrieval of the origins of the faith, the beginnings and growth of the church, and the basic beliefs, ethics, and worship life of Catholics.

Bishop Knestout summed up the overall agenda for this work saying: "It is my hope that the guides on inter-religious education will be of practical help to educators and the lay faithful of each community in speaking to their own students about the teachings and practices of the other faith community. These materials should ensure a respectful and accurate presentation of the beliefs and practices of both Catholicism and Islam."





Helping, Fixing or Serving?



Dr. Rachel Naomi Remen author of the best-selling <u>Kitchen Table Wisdom:</u>
<u>Stories that Heal - 10th Anniversary</u> is a beloved storyteller and a profound voice in the field of health and healing. In the following article she teases out crucial differences between the various modes in which we humans tend to reach out to the world: by fixing, helping or serving. The stories in this book as well as in <u>My Grandfather's Blessings: Stories of Strength, Refuge, and Belonging</u> are some of my favorites. Here is an excerpt from this article.

Helping, fixing and serving represent three different ways of seeing life. When you help, you see life as weak. When you fix, you see life as broken. When you serve, you see life as whole. Fixing and helping may be the work of the ego, and service the work of the soul.

Service rests on the premise that the nature of life is sacred, that life is a holy mystery which has an unknown purpose. When we



serve, we know that we belong to life and to that purpose. From the perspective of service, we are all connected: All suffering is like my suffering and all joy is like my joy. The impulse to serve emerges naturally and inevitably from this way of seeing.

Serving is different from helping. Helping is not a relationship between equals. A helper may see others as weaker than they are, needier than they are, and people often feel this inequality. The danger in helping is that we may inadvertently take away from people more than we could ever give them; we may diminish their self-esteem, their sense of worth, integrity or even wholeness.

When we help, we become aware of our own strength. But when we serve, we don't serve with our strength; we serve with ourselves, and we draw from all of our experiences. Our limitations serve; our wounds serve; even our darkness can serve. My pain is the source of my compassion; my woundedness is the key to my empathy.

Serving makes us aware of our wholeness and its power. The wholeness in us serves the wholeness in others and the wholeness in life. The wholeness in you is the same as the wholeness in me. Service is a relationship between equals: our service strengthens us as well as others. Fixing and helping are draining, and over time we may burn out, but service is renewing. When we serve, our work itself will renew us. In helping we may find a sense of satisfaction; in serving we find a sense of gratitude.

Interwoven in the full story are two unforgettable stories of service; the first about an emergency room physician and a newborn child, and the second, a searing personal story of Remen's own experience with suffering, and the gift she received from a young woman who will probably never know just how much her compassionate actions meant.
