for families. This is a reality we need to consider. It follows then that some of our schools do not support Charter Schools, while others do.

The following is a **snapshot of** *School Choice* options:

	-	·
Option	Benefit	Pass in WA?
Vouchers	Benefit: Low-income families, children failing in school or children with special needs have greater access to private schools.  How: Education dollars "follow the child" to pay for tuition.	Washington's Blaine Amendment bars State money from supporting faith-based schools, thus making Vouchers an unlikely choice.
Scholarship Tax Credits	Benefit: Low-income families, children failing in school or children with special needs have greater access to private schools.  How: They provide incentives for corporations to donate to scholarships for children.	This type of program is a possibility in WA. Scholarship credits are working in other states. They help even the playing field for low-income students.
Education Savings Accounts	Benefit: Families control their education dollars to be spent as they see fit for their child.  How: Personal accounts store a child's state education dollars. Families can spend the money on many things including tuition, textbooks, and tutoring.	Arizona is the only state using this type of program
Public Charter Schools	Benefit: Opportunities for children to attend a different kind of public school.  How: They are allowed to innovate and develop specialized education programs. However, they are still accountable to the government.	Charter School Initiative 1240 is on the BALLOT this year. Charter Schools differ from one-another in how they are run and, in turn, how successful or unsuccessful they are for children.



## POLICY Early Education

Private schools are leaders in early education. As such, WFIS is included in conversations and workgroups formed to guide the State in its commitment to educate young children.

Until recently, the Department of Early Learning (**DEL**) focused mostly on **health and safety** through licensing. With the federal Race-to-the-Top--Early Learning Grant, DEL has the funding to **refocus** on **quality control** through its **Early Achievers Program**.

DEL is offering substantial support in the form of coaching and program development. There is also monetary incentive for schools to participate. The higher a school scores, the more support it receives. With our schools running high quality programs, the question is: What are the Risks?

Some Schools are weighing the beneficial outcomes of participation with the school resources it takes to be a part of the program. Others are considering whether State intervention threatens a school's independence.
