# **Employee Bonuses and Gifts**

It's that generous time of year again when some parishes and schools give holiday bonuses or gifts to staff members and volunteers. It is VERY important that these are handled correctly so that any tax problems can be avoided.

Any cash bonus to an employee is considered taxable income and must be run through payroll regardless of amount. Gift cards and gift certificates are considered cash bonuses according to the IRS and are taxable.



Gifts and bonuses to volunteers are slightly different.

As long as the gift or gift card is less than \$100, it is not taxable. If a volunteer receives more than one bonus or gift during a calendar year, and the total exceeds \$100, the total is considered taxable income.

We do not discourage holiday bonuses, but the payments must be handled correctly. Here are the best methods for processing employee bonuses:

- You can issue the employee a check from accounts payable and then process
  it as an additional pay code and a salary advance. This insures the bonus is
  taxed.
- ADP offers, as part of their year-end process, a separate payroll in which they specifically process bonuses. ADP will charge a fee for this service.
- You can add it to their normal wage and include it with their regular paycheck.

Some of you have received a request from the Centers for Medicare and Medicaid Services (CMS) asking you to complete the Group Health Plan Report for Coordination of Benefits for their Data Match Project. Benefits Services wants you to know that these letters are legitimate and we are required by law to complete the reports within 30 days of receiving the requests. Please send your letter to Benefits Services by fax or email and we will take care of answering the questions and sending the information to Medicare.

Most of the employees they are asking about are those who are 65 or older and still working for the Archdiocese or have recently retired. Medicare is trying to make sure the correct medical insurance is being billed.

## Pension Contributions for Women and Men Religious (Non-Ordained)

Effective July 1, 2012, parishes and schools are required to make a pension contribution for eligible employees who are religious (non-ordained) women and men. The pension payment should go directly to the religious institute. The pension amount is the same as for lay employees -6% of the annual salary. ### Washington State Reseller Permit

As a reminder, Washington State replaced resale certificates with reseller permits in 2010. After discussions with the state, they advised us that we need to use **ONE** reseller permit for all of the organizations within the Corporation. Because it is in the name of the Archdiocese, parishes and schools must be diligent about the proper use of the permit.



Please remember that we are NOT exempt from paying sales tax. Certain fundraising activities, however, are exempt from the sales tax. In these situations only, the reseller permit can be provided to the vendor to waive the sales tax. Examples of qualified fundraising purchases would be:

- Items purchased to auction off at a school auction
- Catered meals served at events where attendees must purchase a ticket to attend

Essentially anything purchased with the intent of reselling at a fundraiser would be exempt from sales tax. Items consumed at these events, such as flowers, decorations, plates, napkins, etc. are not exempt from sales tax.

We understand that we may run into problems with vendors who don't understand our corporate structure.
