A Dozen Things Catholic School Board/Council Members Should Do in 2013

1. Pray

- a. Pray before and after each meeting we have much for which we are grateful
- b. Attend mass and notice the students who are in your respective school/s acknowledge them as members of the parish community
- c. Attend mass together as a board at least once a year
- d. Attend a school liturgy
- e. Participate in faith-in-action projects with your students

2. Set high standards

- a. Recruit a diverse, visionary and hardworking board membership
- b. Expect productive committees that set goals that advance the operational vitality of the school and reach them
- c. Review and adhere to your governing documents or bylaws
- d. Have well-run meetings with set agendas and conclude with assigned action items
- e. Take educated risks to raise the teaching/learning standards to achieve excellence

3. Take a field trip

- a. Visit another Catholic school that is doing something that your school is not, for example, blended learning, implementing the Year of Faith, extending the school day, an effective middle school program
- b. Share what you have learned with others on your board
- c. Conduct a Competitive Analysis-determine what you do well and what needs improvement to be competitive

Census Data and How it Affects Your School's Planning

The current census data impacts enrollment at some point in two ways. First, one in four counties, nationwide, show that minority populations now total more than 50 percent in the 5 years and under demographic. This is a sign of future changes in the race and ethnicity makeup of our ever growing and changing United States.

Given your schools' changing demographics, to whom will you market now and in the future?

Second, this same data show that births have been declining for both whites and minorities. Currently the national birth rate is at its lowest point since the advent of reliable birth rate record keeping, which began in 1920. Although the birth rate is down across the board for



all ethnicities, since 2008 the percent of births has declined more for whites (11.4 percent) than it has for minorities (3.2 percent).

Based on the birth rate in your counties and infant baptisms of your feeder parishes, what is your projected preschool and/or kindergarten enrollment for the next five years?

Textbooks Vs eBooks

While textbooks are still the top choice for many classes, eBooks are giving them a runfor their money.

Textbook

Markup on physical textbooks ranges between 33% and 35%.

A look at rentals

Renting physical or electronic textbooks is another option for the cash-strapped student. Here is a quick overview:



Students can usually rent a textbook for 33-55% off the cost of the new textbook



The National Association of College Stores says nearly all of its 3,000 member stores offer textbook rental programs; this is up from 300 in 2009.



Chegg.com

Sites like Chegg allow students to buy or rent textbooks, as well as rent elextbooks. They also offer a Reader that allows users to interact with their eTextbooks



The Kindle Store's eTextbook prices vary, but Arnazon claims users save up to 80% when renting; users can choose how long they rent them, too.
