A LEGISLATIVE UPDATE FOR MEMBER SCHOOLS

Participating in the Process

Our school community members have been participating in the legislative process by attending hearings, calling legislators and meeting with legislative staff.

Legislators like to hear from practitioners and informed constituents to help them understand how educational policies affect independent schools.

Together WFIS and its school members make sure that the consequences of State regulations do not infringe upon a school's right to run a mission-based program.

We celebrate the teachers, administrators, and students who participated in the legislative process this year. WFIS is looking forward to making participation even easier next year for all who are interested!

Here is the **Bill Update**:

School Programs

Moving forward: <u>SB 5496</u>: Authorizes approval for private schools to run online programs for grades outside those offered by their brick and mortar school.

Moving Forward: <u>HB 1283</u>: Changes compulsory school attendance age from eight to six.

Died: <u>SB 5588</u>: Required an analysis of how school districts use school days. This Bill challenged the use of 1/2 days and late starts.

Died: <u>HB 1215</u>: Concerned the exemption for property owned by nonprofit religious organizations.

Safety

Moving Forward: SB 5620: Changes school safety-related drills so that schools must complete no fewer than four drills for lockdowns, previously one, and four drills for fire evacuation, previously six.

Moving Forward: SB 5197: Requires public schools to implement a panic alarm system that uses technology to expedite law enforcement's arrival and effective response in the event of a threat at a school.

Moving Foward: <u>HB 1541</u>: Expands the types of medications that public or private school employees may administer to include nasal spray.

Moving Forward: <u>HB 1968</u>: Aligns building code for after school programs with school building codes so that there are not two sets of regulations.

Moving Forward: SB 5563: Regarding training for school employees in the prevention of sexual abuse.

Early Learning

Moving Forward: <u>HB 1723</u>: Creates a legislative task force to examine options for early learning.

Died: HB 1671: Childcare Reform

Moving Forward: <u>HB 1547</u>: Creates an exemption from licensing for schoolage **recreational** programs.

The 2013 Legislative Session ends April 28th

How will the Same-Sex Marriage Law Affect School Policy?

Admissions Process Recalibrated by Suzie Hanson

According to an article written by Grover J. "Russ" Whitehurst, director of the Brookings Institution's Brown Center on Education Policy, New Orleans and New York City are using "an algorithm created by a Nobel Prize winner to match students to the schools their parents prefer."

Would using a system that matches students to schools and schools to students alleviate the drama of the admissions process and help schools enroll the students who would be most successful at their schools?

When I worked as an Admission Director, I dreamed about this possibility. I could imagine that instead of waiting the two weeks while a family whose child got in to all five schools he/she applied decided where to go, and put all other folks on hold, the algorithm would place the student immediately and in turn, all of the other families would know their place as well.

It seems like a dream: No more drawn-out admissions season; No more deposits sent to hold a spot at one school while hoping for a different school; No more competition for the same kids, while other great kids are overlooked.

No answer is perfect. We will hear the complications of using the algorithm in good time. I am, however, excited about the possibility of the selection process being less stressful for all involved, even if it is just a dream!

Students Attend and Graduate from 4-Year Colleges at High Rates

Students in private high schools are more likely than those in public schools

to receive a diploma, attend a four-year college, and ultimately earn a bachelor's degree, according to data complied by the National Center for Education Statistics (NCES) at the request of CAPE.

The findings hold true regardless of the race or ethnicity of students and should be of interest to policymakers determined to improve rates of high school graduation, college attendance, and college completion.
