A LEGISLATIVE UPDATE FOR PRIVATE SCHOOLS

**Advocacy: Making Change** 

The need was clear. A middle school graduate was dreaming of becoming an actress. She knew she needed a flexible high school schedule to make auditions and a typical school was not going to be flexible enough. More than anything though, she wanted to graduate high school from the school she loved, Renton Christian School.

Renton Christian School did not have a high school program. However, the Principal had a solution: an online program designed to align with its curricular and religious studies. There was one problem: OSPI had not yet updated its regulations to include an approval of private schools with online programs.

Erik Konsmo, the Principal of Renton Christian, solicited some help from Jami Lund,Freedom Foundation, Suzie Hanson, WFIS and Representative Mark Hargrove from the 47th District. They put their heads together and wrote legislation, talked to legislators and, with the help of the actress/student and her dad, as well as Liv Finne from the Washington Policy Center, testified at hearings.

Senator John Braun from the 20th District got on board and championed the Bill in the Senate. This Bill eventually passed both houses and Washington now has an Online Private School Bill, SB 5496!

WFIS worked together with a student, a parent, a Principal, legislators and other nonprofit organizations to pass this bill. As a result, a high schooler can work on her art while attending her high school of choice. This is an example of how WFIS works to open doors for all of Washington's students.

Private School Advisory Committee Legislative Report

A *Thank You* to all of the schools that participated in PSAC's *Online Education Survey*.

**WFIS** worked with **Laura Moore**, the Private Education Program Coordinator for OSPI, and **Dr. Duane Schafer**, Superintendent of Schools for the Catholic Diocese of Spokane in a subcommittee of the Private School Advisory Committee to complete a Legislative Report due in January on Private Schools with Online Programs.

Survey Results:

Of the schools surveyed:

- 30% are considering BLENDED LEARNING options for their students.
- 10% are considering opening an ONLINE SCHOOL.
- Almost 45% indicated they will not have students online.
- 83% of the schools interested in opening an online school will do so for their current grades.

- The perceived obstacles to adding an online program for most schools are the start-up costs and the lack of technological assistance.
- The perceived benefits are the ability to diversify the courses offered and the ability to differentiate learning for students.

# Charter Schools = **Public** Schools

Parents get confused about what makes a Charter School and a Private School different.

#### **The Common Core**

Private schools across the state are using Common Core as a **tool** to affirm current curriculum, inform decisions about changes, and assure parents that within the context of this tool, private schools are measuring up to or surpassing the standards.

Smarter Balance Assessments, standardized tests that reflect the Common Core curriculum, are being field tested this year with 20% of public school students participating. WFIS is working with OSPI to assure that private schools will have access to the test as desired.

There are two components to the SmarterBalance Test: A computer adaptive part and a written performance part that includes a writing sample.
