TULIP COVERAGE (SPECIAL EVENTS INSURANCE)

In general, the transition to the TULIP program has gone very well but we do have one item to clarify. The application asks if liquor will be sold at the event. If you answer "No" the certificate will indicate no liquor liability coverage even if liquor is being served (but not sold). This has created some confusion.

What the certificate does not say is that <u>Host Liquor Liability coverage is included for all events and is built into the standard General Liability policy</u>. Host Liquor Liability coverage provides coverage for events when alcohol is not being sold but rather served at no charge.

The TULIP program certificate will only show a Liquor Liability coverage limit when the additional coverage is purchased for liquor being sold at the event.

Our TULIP program contact is aware of this issue; they need to do some reprogramming of their website to fix it. For now the important thing is that you do get the coverage you request.

UPDATED PARISH HUMAN RESOURCES POLICY

Dear Brother Priests and Pastoral Coordinators,

I'm writing today to remind you that the final Build Hope collection will be conducted on the weekend of September 13-14 and to urge your support for this important special collection.

As you know, the Presbyteral Council approved a change in the collections calendar beginning in 2015, replacing Build Hope with the Catholic Campaign for Human Development (CCHD) in September and creating the NORTHWEST CATHOLIC/Catholic Communications Campaign special collection in January. Because other collections were consolidated, this change did not increase the number of annual collections.

Replacing Build Hope will allow us to increase support in the future for the many worthy CCHD projects while creating an ongoing source of funding that will be credited directly toward the NORTHWEST CATHOLIC portion of parishes' ACA responsibility. Called to Protect: Train-the Trainer

September 22 & 29, 2014

No particular educational background is needed to be a *Called to Protect* Trainer. Successful trainers may include clergy, religious, employees or volunteers who share a commitment to protecting children. Teachers, counselors, case workers or health care professionals also make great trainers.

Qualities of a Successful Safe Environment Trainer:

- → Comfortable speaking/presenting in public
- Level headed when under stress
- → Emotionally and psychologically stable
- Compassionate towards others
- Reasonably objective about sexual abuse
- Comfortable discussing sexual issues
- Able to maintain confidentiality
- Motivated to participate in the program
- Current with Safe Environment training
- Willing to attend training updates

Approved trainers will participate in a two-day Train-the-Trainer certification that will prepare them to lead any of the *Called to Protect* trainings in parishes, schools or other archdiocesan agencies.

Called to Protect: Train-the-trainer is a two-day class and participants must complete both days in their entirety.

Cost of training is paid for by the Archdiocese of Seattle. Lunches and all training materials will be provided free of charge. *Cancellations must be made within 24 hours of the training or the participant's parish or school will be charged a \$25.00 cancellation fee.*

All trainers must obtain an endorsement from the <u>appointed pastoral leader</u> (Pastor, Priest Administrator, Pastoral Coordinator or Principal) who must sign the application.

Application may NOT be signed by PAA or SEP Coordinator.

Clergy who wish to become a trainer must obtain prior approval from Archbishop Sartain.
