Fulcrum Foundation Holds Seventh Annual Chairman's Breakfast

Dear Fulcrum friend,

Journeys in Catholic Education was the theme of the Fulcrum Foundation's Chairman's Breakfast, held on November 13 at the Harbor Club in downtown Seattle. One hundred supporters of Catholic education enjoyed a program that highlighted the journeys of our schools, our teachers and the families Fulcrum supports.



St. Alphonsus' teacher Mary Johnson described the journey to multi-grade, single gender classrooms that have made a positive impact on their school's learning community. Teachers Liberty Sponek and Betsy Gottschalk of Assumption School in Bellingham detailed an impressive garden project, the produce of which is sold to raise money for a sister school in Cambodia. The Woldsalassie family shared their journey from Ethiopia to the United States and expressed undying gratitude to all the donors who help support them with tuition assistance. Daughters Bethel and Ruth came to the microphone to recite their favorite poems and quotes, easily the most charming part of the morning. Teacher Phil Moore from St. Patrick School in Tacoma detailed his cross-curricular approach to educating the whole student. The 5th grade students built a grotto incorporating learning from math, physics, technology, social studies, art and religion.

Guests were also updated on the Fulcrum Foundation's grant programs, which exceeded \$2.3 million in awards this past year for tuition assistance, schools in need, and teacher/staff excellence initiatives. In its short 8 year history, Fulcrum is on pace to distribute its 14th millionth dollar toward Catholic schools and Catholic school families.

IRA Distributions are Tax Free if Given to Charity

A rare charitable gifting opportunity has been extended. Until December 31, 2009, if you are over the age of 70 $\text{Å}\frac{1}{2}$, you are eligible to make an IRA distribution to the Fulcrum Foundation. Your IRA distribution made directly to Fulcrum will not be included in your federal or state taxable income! This qualifies for an IRA Required Minimum Distribution. There is a maximum limit of \$100,000 on the distribution annually.

We advise you talk to your tax adviser before making a decision regarding this tax free IRA distribution.

House Votes 225-200 to Extend Estate Tax

On December 3, 2009 the House passed the Permanent Estate Tax Relief for Families, Farmers and Small Business Act of 2009 (PETRFFSBA). The Act would make the \$3.5 million estate tax exemption and the 45% estate tax rate permanent. It would also continue the existing rules that permit estates to pass on property with a stepped-up basis. >>>read further
