# New Email Server for the Chancery: Secure web mail

In order to protect the personal and financial information of Archdiocesan employees, volunteers, students, and others who do business with us, we have implemented encryption requirements on email messages leaving our mail server. If a message is sent which contains privileged or confidential information, the message must be

transmitted in an encrypted form. If our mail server is unable to establish an encrypted connection to yours, you will instead receive a message notifying you that a secure email has been sent. This message will contain instructions for how to access the information you were sent.

If you have not previously created a Secure Web Mail account, the first message you receive will be a welcome notice. Click on the Activate your personal account link (in blue text in the email message) to set up an account on the Archdiocesan Secure Web Mail server.


## <u>Welcome Maggie Parros:</u> <u>Insurance Program Administrator</u>


# <u>Fulcrum Foundation's Assistance to Schools in Need Program</u> <u>- Applications now being accepted!</u>

The Fulcrum Foundation's Assistance to Schools in Need Program is designed to assist schools facing financial challenges including anticipated budget deficits, capital projects (planned and emergency) and one-time expenses related to maintaining the excellence of the academic offerings of the school.

Any school in the Archdiocese of Seattle is eligible to apply for a grant through this program. The maximum amount that a school may apply for is \$50,000. Grants awarded through this program are intended for needs in the following categories:

- · Budget anticipated budget deficit at fiscal-year end
- · Capital Projects planned, emergency or other critical updates to facility
- · Expenses one-time or unanticipated costs related to maintaining the excellence of the academic offerings of the school

The application is available for download on Fulcrum's website (<a href="www.fulcrumfoundation.org">www.fulcrumfoundation.org</a>). Applications must be mailed (postmarked) by October 31, 2014, to be considered for funding. All applicants will receive notice of the outcome of their request in late January 2015. ### **Insurance Claims reporting procedure**

We have received some questions regarding the new claims reporting procedure. It is more formal than the previous arrangement but we think it is efficient. The attached chart indicates the steps to take and the disposition process for the incident/claim. One thing to note, it will help speed things up if you complete the Incident Report form prior to calling Sedgwick - (<a href="http://www.seattlearchdiocese.org/Assets/PFS/5051">http://www.seattlearchdiocese.org/Assets/PFS/5051</a> IncidentReportingForm.pdf) That should insure that you have all the necessary information before making the call. We know these changes are difficult and we do appreciate your continuing cooperation. -Ed Williams



#### **2014 Update:**

This week the ACA office mailed 840 letters to follow up with donors who made a pledge to the 2014 appeal but have not yet made a payment. These donors have a total of \$330,000 in outstanding pledges. This effort last year collected ½ of the outstanding amount that could have otherwise gone uncollected, which would have reduced the amount of rebates to our parishes.

The Annual Appeal office will continue to send campaign and rebate status reports on a monthly basis. Individual detailed donor reports are uploaded through ShareFile on the last Thursday of each month or you may request one at any time. 
