



2015-2016 Archdiocesan IOWA Form E Testing Consortium Overview

Dear IOWA Form E Consortium School Leaders,

This year, 28 IOWA member schools have continued to do an excellent job of working together to test during a common testing time, develop data teams to analyze student data, and to use various online tools through Data Manager and the Office for Catholic Schools to assess student performance and track data trends. The Consortiums quick link has been a helpful resource to secure all relevant resources in one central location for your convenience. The OCS Tech Team continues to pre-populate various tools from the annual data collections to support self-study and accreditation, annual data reports including the Indices of Vitality reports.

We continue to look at the OCS Strategic Plan as our guiding document. Goal 2 provides direction for refining our academics, and Action 5: "Accountability through Assessment" requires us to assess our students' academic achievement with a common summative test in grades Pre-K – 8 and Category 1 high schools. Our OCS work is to begin making an informed decision regarding which test to administer. Our Superintendent, Dr. Patrick Haggarty, has tasked a sub-committee of the Executive Principals to develop criteria and review assessment options. Kristin Dixon will be sending out an assessment survey later in May to secure input from all 63 elementary school leaders. The sub-committee will then meet to review the criteria and then on July 7th and 8th, listen to presentations by various assessment publishers. The committee will offer the results of their findings to the superintendent and the Executive Principals for a final decision in the winter of 2016. The OCS anticipates implementing the common summative test in the 2016-2017 school year. Therefore:

ARCHDIOCESAN IOWA-Data Manager TESTING CONSORTIUM - Fall 2015 Testing Program Parameters:

*The Archdiocesan IOWA –Data Manager Consortium will continue to support the IOWA - 2011 norms, Form E test through the 2015 -2016 school year. We are grateful to share a

15% discount on Riverside testing materials and 25% discount on all products purchased through the Riverside Scoring Center. This 2015 pricing information will be posted on the IOWA forum.

***FALL Testing Window: Thursday, October 15 through Friday, October 30, 2015** - Our testing window continues to reflect the fall mid-point for the national norms' comparison. Background: The fall, mid-year, and spring norms are empirically established. By definition, the fall mid-point is set at October 22nd and the spring mid-point is set at April 30th. When students are administered the IOWA Tests at these points, their scores are reflective of the national averages from the students in the standardization sample. Local data should be available before Thanksgiving vacation. The Archdiocesan fall testing window follows the annual testing pattern of the last two weeks in October.

*The Office for Catholic Schools will continue working with Riverside Publishing to assist each consortium member school with using **bar codes** containing a unique student ID number to each student testing within the consortium. The OCS will work with the local school testing coordinator to develop the student rosters accurately to reflect this additional tracking information. This step ensures that our student data is collected in a more standardized and accurate way. ALL participating schools will receive directions in late May to create student lists for barcoding preparation.

***Consortium Testing: Grades 3 - 8**

***Costs:** Each school is responsible for their local building costs. The Office for Catholic Schools will be responsible for costs associated with bar coding costs to rolling-up test scores of participating schools at the Archdiocesan level. CogAT7 is an optional testing choice as well as the online Interim assessments for ELA and Math. - 4) **Riverside IOWA Pre-Test Workshop:** Please hold **Tuesday, September 15, 2015** from 9:30 a.m. to noon at the large Isaac Orr Conference Room at The Chancery. Valerie Kosinski and Tyler Brown from Riverside will walk through all directions and bring your school's testing materials to the meeting. ALL Testing Coordinators should plan on attending to receive your local school packet.
- 5) **Post-test Training in early December:** Dates are being secured at this time.

Riverside will honor the archdiocesan parameters and offer optional testing materials for your school's local needs. Ie: Some schools might choose to test at a Grade 2 (Level 7) level or try CogAT7.
