Supplemental Coding and Legends – Fall 2015

BAR CODE: The purpose for coding is to allow schools to disaggregate or pull information on individual students or groups of students in any particular area of interest.

- Each school data file has been designed to pre-identify students so no bubbling needs to occur at the Fall testing time. (Exception: New students)
- All coded data will be embedded in the BAR CODE.
- Bar Code Spreadsheets are due to the OCS on or before Friday, August 14, 2015.
- Bar Code Labels will be mailed directly to the school. Each school's Testing Coordinators will receive their Administrator's Scoring Packet at the Tuesday, Sept. 15th IOWA Pre-Test meeting with Valerie Kosinski, HMH/Riverside Publishing.

PROGRAMS OVERVIEW:

- We have modified PROGRAMS options to reflect the Archdiocese of Seattle
- More than one Program item can be marked in the PROGRAMS area
- Each PROGRAM marking can be more defined by using the Test Administrator Use columns
- Using the PROGRAMS field in the BAR CODE requires checking data file each year for students who exit PROGRAMS or withdraw from the school.

TEST ADMINISTRATOR USE Section:

- TEST ADMINISTRATOR USE section can further define what has been identified in the PROGRAMS.
- There are two ways to use the TEST ADMINISTRATOR USE:

Code Column which contains bubbles A through T

The **COLUMNS** to the right labeled A through J with 9 options to bubble

• A customized legend has been created to guide the use of the bubbling (0 = 1, 1 = 0, up to 9)

TEST ADMINISTRATOR USE ONLY Section: Go to:

- 1. CODE COLUMN and bubble the corresponding letter to the 13 student disability/eligibility categories as defined by the Individuals with Disabilities Education Act (IDEA). In order to qualify for special education, the IEP team must determine that a child has one of the following. You may code multiple disabilities.
- A = Autism
- B = Blindness
- C = Deafness
- D = Emotional Disturbance
- E = Hearing Impairment
- F = Intellectual Disability
- G = Multiple Disabilities
- H = Orthopedic Impairment
- I = Other Health Impaired
- J = Specific Learning Disability
- K = Speech or Language Impairment
- L = Traumatic Brain Injury
- M = Visual Impairment

2. COLUMNS A-J across top of box:

A. Grade student entered the present school

- 0 = if student entered the school in PreK
- 1 = if student entered the school in K
- 2 = if student entered the school in Grade 1
- 3 = if student entered the school in Grade 2
- 4 = if student entered the school in Grade 3
- 5 = if student entered the school in Grade 4
- 6 = if student entered the school in Grade 5 7 = if student entered the school in Grade 6
- 8 = if student entered the school in Grade 7
- 9 = if student entered the school in Grade 8

B. Accommodations and Modifications used during testing

- 0 =Separate setting
- 1 = Extended testing times
- 2 = Scribe
- 3 = Read Aloud

- 4 = Repeated directions
- 5 = Small group/individual administration
- 6 = Student had test administered by ELL teacher or individual providing language services
- 7 = ELL specific test accommodations used
- 8 = Large Print
- 9 =Assistance with the answer document

C. OCS - Accreditation Curriculum In-Depth: Math Textbooks used at the local school.

Please identify the textbook used at each grade level – only one answer option. Ie: Grade 4 students using Houghton Mifflin Harcourt so go to Grade 4 bar code spreadsheet, find Column C, fill in the number 2 = HMH.

September Options:

- 1) Columns D through J are still available for specific local coding. If you decide to track something unique for your school, please make your own **local** Legend and bubble in on the student answer sheets. This information will not be part of the bar codes and consortium data, but you will be able to filter locally through Data Manager.
- 2) New Students can be entered in September and October but their demographic data and coding will have done be done by hand bubbling. This information will not be part of the bar code labels.
