IMPORTANT YEAR END REMINDERS

New Mileage Rate: On January 1, 2016 the Internal Revenue Service changed the rate for standard business mileage from \$0.575 per mile to \$0.54 per mile. For business travel prior to January 1, 2016 please use the form for the effective dates of July 1, 2015-Dec 31,2015. You can find the new mileage form on SharePoint located under Human Resources.

<u>Seattle Minimum Wage</u>: Employers with employees performing work in the city of Seattle are required to pay Seattle minimum wage. The minimum wage requirements are based on an employer's total number of employees. A "large employer" employs 501 or more employees within the United States, while all employers with less than 500 employees are considered "small employers." As a result, the Archdiocese of Seattle falls under the minimum wage requirements of a large employer.

The city of Seattle minimum wage ordinance requires a higher minimum wage for employees not receiving benefits. Therefore, there are two tiers of minimum wage requirements the Archdiocese will follow.

Minimum Wage for employees who receive benefits= \$12.50/hour Minimum Wage for employees that do not receive benefits= \$13.00/hour

2015 Annual Lay Pension Bill due date is January 31, 2016

Mail a copy of the billing report along with your check made payable to A.P.P.L.E to the Benefits Services Office in the envelope provided by January 31, 2016. Please note: if you are late with your payment, your employees may lose investment earnings on the amount that should be contributed to their account. A late contribution is a serious violation of the Lay Pension Plan document and significantly increases the liability of the parish or school as well as the Archdiocese. To reimburse employees for lost earnings we will bill a late charge to locations whose pension contributions are postmarked after January 31, 2016. The late charge is a per-day percentage of the total amount due.

<u>SAFE ENVIRONMENT UPDATES:</u>

Compliance Reminder:

Although compliance forms are not due until Spring, it is important to be getting a head start by making sure that all employees and volunteers (with ongoing unsupervised access to minors or vulnerable adults) have:

- ~ Current cleared background checks (within the last 3 years)
- ~ Have read and signed off on the policies for the Prevention and Response to Sexual Abuse and the Code of Conduct
- ~ Have taken a *Protecting God's Children / Called to Protect for Ministries* foundation course and if required an online refresher course

You can do this by running monthly compliance reports for your parish location or school. If you need assistance with how to run a compliance report, please see the instructions in the online VIRTUS tutorials located here https://seattlearch.box.com/SafeEnvironmentTraining. *Note you must click on the link to access the videos. We have updated the videos on this page, so please view them at your earliest convenience. We require all schools and parishes to sign off on our compliance form, which states that all employees and volunteers are in compliance at their location. These forms will be distributed by our office in the coming months and are due May 2016.

Coordinator Trainings Coming Soon: In the coming months, we will be traveling to selected deanery locations to hold a VIRTUS coordinator training. This will be a session designed to go over the tips and tricks of navigating VIRTUS and we will show you how to fix many of the problems encountered. We encourage you to attend the session that will be closest to you, and to bring your questions with you. 
