

FROM THE OFFICE OF PFS:

Class action settlement checks:

If you received a class action settlement check for about \$92 regarding Stellar Communications (insured by Old Dominion), these checks are legitimate and may be cashed. Finance Council tidbits:

Whether your Finance Council meets monthly or quarterly, you've probably not met during the summer. Now is the time to look at the final numbers for fiscal year 15-16. Also, by sometime in October, you should have first quarter fiscal year numbers, and October is definitely a good time for your finance council to review how those numbers line up against your 16-17 budget so far. Review the Annual Report to parishioners that should be sent out soon. October also puts us very close to the yearly parish stewardship commitment renewal. The finance council could discuss how they might support that effort this year — and if your parish has a stewardship commission might connect with them to find out what they can do to assist. (Also, note that we are accumulating finance council chair email addresses from the parish annual report. We plan to share this tidbit — and again in succeeding quarters — with them by email.)



INSURANCE REMINDER: STUDENT INJURIES

As students return from summer vacation, some reminders about our insurance program might prove helpful. Remember, you do NOT need to report most student injuries to Sedgwick Claims Management (our 3rd party claims administrator.) Only report injuries if they involve a head injury, amputation or death, OR if you believe we have clear liability. A best practice would be to fill out

the incident report form (found on the Archdiocesan insurance website, link found below) for most student injuries and keep internally for future reference.

The Archdiocese has Student Accident Coverage available to students who are injured during school (youth ministry) activities. This coverage is to be used AFTER parental or guardian coverage has been used. The Student Accident Coverage can be applied to fill coverage gaps of the family medical coverage and/or to ease family deductibles. This coverage should be extended when *asked* by the parent. The forms and FAQ's etc. are located on the Archdiocese Insurance website under *Student Accident Insurance Program*.

Covered "group" under Student Accident:

All enrolled students of the Policyholder during school time, while participating in school sponsored and supervised activities, including group travel, including athletics, and football. Coverage also extends to Volunteer Workers of the Policyholder while involved in duties at the direction of the Policyholder.

UPDATES FROM THE OFFICE OF PROPERTY & CONSTRUCTION

Greetings...A request was made a bit ago for an update to the Parish Building Maintenance Manual. This update has been posted to the Seattle Archdiocese, Property and Construction Page under the SAFETY tab. Let me know if your staff need any assistance with this manual.

We are in the process of adding Appendix H – Emergency Preparedness, to the Safety Manual. There has been a constant stream of inquiries related to this issue and this appendix will assist you and your employees. The Appendix will be posted/you will be contacted in a few weeks in conjunction with our Fall Safety Training. A reminder if this isn't done all ready, have your employees sign up for the fall safety training.

A common question asked by PAA's and Facilities Managers is "Do I need to attend the fall safety training?". For any new hires or first time PAA's, I would encourage attendance or if job description has maintenance and custodial duties, please call and we can discuss further specific training with these duties and your other PAA duties. Keep in mind all supervisors of employee's must be first aid trained. When you obtain training, use a provider who can certify a two year refresher after training. Some providers can only certify you for an annual refresher training.

The Seattle Archdiocese, Property and Construction Page is going under construction shortly and will be reformatted to better assist you.

Dear Father or Pastoral Coordinator:

Parishes in the Archdiocese of Seattle have taken October Mass counts for at least the past 35 years, and these counts have informed everything from the opening of new parishes to the assignment of parish staff. The need for this information continues, and it's time again to ask all parishes, missions and stations that have regularly scheduled weekend Masses to report on attendance at those Masses.

Please take a count of attendance at all scheduled liturgies in your parish and any associated missions or stations on the **FIVE** weekends of October: **October 1-2, 8-9, 15-16, 22-23 and 29-30, 2016**. We know from past experience that the weekend nearest to Halloween can have a lower than usual attendance, but please do the count that last weekend anyway.

The form with this letter can be used to record and report the counts by email, fax or regular mail. The form will also be posted on the diocesan website (www.seattlearchdiocese.org/cwm) and can be downloaded, completed, and sent directly to us. You are also free to use your own form if you prefer, just as long as you provide all the information that is requested: the day the Mass is offered (Saturday or Sunday), the beginning time of the liturgy, the language (if not English), the location (parish, mission or station) and the total attendance. Most parishes assign the responsibility for the counts to a single person (staff member, parish council member, usher, etc.) to assure that all counts are conducted in the same way.

A few reminders:

- 1. Count attendance separately for any parish, mission, station, satellite, campus center or other site where a Mass is regularly scheduled.
- 2. Count everyone in the church including children, the liturgical ministers and the choir. If children are dismissed for Liturgy of the Word, the count should be taken after they return.
- 3. Direct the counters to **COUNT** those in church. **Please do not estimate** attendance or count half of the church and multiply by two. These counts need to be as accurate as possible.
- 4. If unusual circumstances affect attendance on one of these weekends (e.g., beginning of the hunting season, a parish auction, First Communions, a single Mass for the entire parish), please note this on the form. Alternatively, you may count attendance the first weekend in November and note the substitution.

Please return the form by November 5th if at all possible. You may submit the form on the Archdiocesan website, send it by e-mail (marybethc@seattlearch.org) or return the information by mail (710 9th Avenue, Seattle WA 98104-2017) or by FAX (206-274-3161). Please keep a copy of the completed form for your records. If you have questions or concerns, please e-mail or call me (206-382-4272).

Falls

With predictable regularity, falls continue to be a leading cause of accidents and deaths on the job. Falls include those on the same level (floor, ground), as well as from one level to another (stairs, ladders, roof, etcetera). They can be caused by either or both of two reasons—an unsafe action of an individual (hurrying, overreaching, improper use of equipment, etc.) or unsafe condition of the situation (poor housekeeping, unguarded opening, surface condition, etcetera).

Good footing is the best way to avoid falls and good housekeeping is the best way to ensure good footing. Trash, wires, and slippery areas caused by water, grease, or oil can cause falls. Watch footing when working on slick flooring and poorly lit areas, where floors are uneven from room to room, and where surfaces are uneven from broken concrete, cracked asphalt or curled rugs. Always look in the direction you are walking. Avoid carrying large objects that may block your view of a safe walking path. Walk slowly on stairs and use handrails to secure your step.

Cover, guard, or mark spills, potholes, and floor openings. Protect them with warning cones, guardrails, or toeboards. Except for normal doorways, protect wall openings and stairways through which someone could fall. The protection should be sufficiently strong and secured to prevent it from being removed.

Makeshift ladders or incorrect ladder selection can cause falls. Choose the ladder that's made for the job. Be sure it's in good condition and placed securely. Face the ladder and keep both hands free while climbing.

Preventing falls is a matter of common sense. Watch where you're walking. Take careful steps when you walk and choose and use equipment properly.




