# HOLIDAYS FOR FULL-TIME EMPLOYEES

(Excluding those with covenants)

Please refer to Schools Policy 3.26 HOLIDAYS for questions concerning paid holidays for full time, support staff employees. Administrators should include holidays when calculating the number of days a support staff employee is budgeted to work (e.g. secretary is scheduled to work 180 instructional days, 10 days before the school year starts, and 10 days after the school year ends.) The ten recommended days are listed in the policy. Breaks in the school year are NOT holidays.

Schools Policy 3.29 VACATION There were some questions concerning Support Staff employees and Veteran's Day. This was a paid holiday since most schools were not in session. Unless the employee's specific work agreement stated this was a holiday, support staff employees would need to work that day, use a vacation day, or not be paid for the day. This is a change from past years.
