### What is Needed for Schools to be Catholic?

Last week, I attended the NCEA conference in St. Louis. While one of my favorite images was of the sweet Dominican sisters in full white habit carefully dining on ribs at Sugarfire Bar-b-que, it was Fr. Nuzzi's talk "Irresistible Catholic Schools" that challenged me and provided clear and practical advice.

Fr. Nuzzi addressed the state of the question, "What is needed for schools to be Catholic?" While we can look to the National Standards, the accreditation process, and Church documents, he made particular reference to the doctrine of the Trinity as the foundation for our Catholic schools. "When we are in community, we are most likely like God...Trinity is the primary model for the school, for God is relationship."

How to market and build relationship? Fr. Nuzzi spoke of some best practices.

- · Interview prayer from a brochure of prayers, the parent chooses a prayer to say with the principal to begin the interview. The parent mentions the prayer intention prior to the prayer.
- · Birth and baptism celebrate baptism with a free-month coupon for pre-k
- · School Tours be specific about the role and training of the office staff, as the first face and voice of the school
- $\cdot$   $\;$  Information sessions for real estate agents, business and political leaders

When we gather <u>Thursday</u>, <u>May 4</u> for the All Principals Meeting at the Palisades, we will celebrate and affirm our schools who have navigated the accreditation process this school year, and we set the stage for sharing our school, region and OCS goals.

## **Employee Agreements**

The 4/10/17 update contained the definitions for "WHICH COVENANT OR WORK AGREMENT TO USE?" Please continue to refer to that list as you do employee agreements. Teachers must be working ¾ time in order to qualify for paid benefits. The definition below is to be used as you discern, "Who is a teacher and should a covenant be issued?" Preschool teachers should be issued a covenant.

### **TEACHER DEFINITION**

A teacher is an employee whose *primary duty* must be that of activity in the field of teaching:

- provides education for pupils assigned to his/her care in a formal and ongoing learning environment, carried out at
  a school or other place of education where instruction and imparting knowledge are the primary emphases, AND
- uses lesson plans to facilitate student learning, follow a course of prescribed course of study (curriculum) and provide instruction in religion, literacy and numeracy, craftsmanship or vocational training, the arts, civics, community roles, or life skills, AND
- has the responsibility for student discipline, classroom management, and communicating with parents regarding the behavior, academic progress, and/or wellbeing of the child, AND MAY INCULDE
- duties that extend beyond formal teaching, including accompanying students on field trips, supervising study halls, helping with the organization of school functions, and serving as supervisors for extracurricular activities.

E-Rate & Technology

### **E-Rate Task Force**

E-Rate is providing considerable school technology funding for Internet service and classroom wireless network projects. 2017 applications for E-Rate funding are 25% complete. This is a summary of the funding received in 2016 and projected 2017 funding. 31 schools received E-Rate 2016 Internet service funding. 51 schools (72%) are projected to receive E-Rate funding in 2017.

E-Rate Equipment Funding: 2016 - \$80K, 2017 - \$80K (projected)

E-Rate Internet Funding: 2016 - \$105K, 2017 - \$140K (projected)
