Last week, we hosted new elementary school teachers for a one-day in-service. One of our goals for the day was to give them a chance to connect with one another, and share answers to four basic questions. For you today, I have placed the first three questions in word clouds – the greater the size of the word, the more prominent in their responses. What did I notice?

- What are your hopes for the year? Teachers hope for the ability to build community in their classrooms, to inspire faith and learning. They know that the key to a great year is to build relationships with students and their families.
- What are your greatest fears? Teachers worry about teaching the Catholic faith, about the interactions they might have with families or colleagues, management of students, and how to juggle their work and home lives.
- What suggestions could you give your administrator? Teachers have plenty of suggestions! Clear communication, and expectations topped the list. Teachers want honest feedback. They want to see you in their classrooms, but they also hope that you won't micromanage them. Teachers truly want a mentor to help navigate the first year.
- What is your biggest, most pressing question right now? This is a great list! Perhaps a best practice is to review your teacher handbook to make sure that you have all these questions answered.

#### Aesop / Frontline Absence and Time Solution

All teaching staff should **now** be entered into the substitute management system. All former staff should have been removed. Teachers may contact and assign substitutes if you wish.

Direct the teachers to access the AESOP training document and video (click here) to review how to invite and assign a substitute of their choice.

**REMEMBER:** The substitute hours will be approved at the school and sent to Payroll. Schools have the responsibility to have a "check out" process for substitutes at the end of their day to enter their hours into Ulti Pro, in order for them to be paid. We are continuing to update the substitute status and availability daily.
